Section 708A Cleansing Notice

Dateline Resources Limited (ASX Code: DTR) (**Company**) hereby confirms that a total of 265,862,055 Ordinary Shares (**Shares**) were issued on 13 December 2016 without disclosure to investors under Part 6D.2 of the *Corporations Act 2001* (Cth) (**Act**) and states that this notice is given to ASX Limited (**ASX**) under section 708A(5)(e) of the Act in compliance with the requirements of section 708A(6) of the Act. The Shares were issued at a price of \$0.01 per Share.

The Company states that as at the date of this notice the Company:

- (a) has complied with the provisions of Chapter 2M of the Act as they apply to the Company;
- (b) has complied with the provisions of section 674 of the Act; and
- (c) is not aware of any excluded information for the purposes of section 708A(6)(e) of the Act, being information:

 - (ii) that investors and their professional advisers would reasonably require for the purpose of making an informed assessment of:
 - (A) the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
 - (B) the rights and liabilities attaching to the Shares.
